- 1.3 My/our Liability to Forest Produce Limited under this guarantee shall not be reduced, discharged or otherwise adversely affected by any act, omission, matter or thing which would have discharged or affected my/our liability had I/we been a principal obligor(s) instead of a guarantor, or indemnifier, or by anything done or omitted by any person which, but for this provision, might operate or exonerate or discharge me/we or otherwise reduce or extinguish my/our liability under this guarantee.
- 1.4 I/we, as principal obligor(s) and as a separate and independent obligation and liability from my/our obligations and liabilities under clause 1.1, agree to indemnify, and keep indemnified, Forest Produce Limited in full and on demand from and against all and any losses, costs, claims, liabilities, damages, demands and expenses suffered or incurred by Forest Produce Limited that arise out of, or in connection with, the Guaranteed Obligations not being recoverable for any reason or any failure of the Company/LLP to perform or discharge any of its obligations or liabilities in respect of the Guaranteed Obligations.

CREDIT ACCOUNT TERMS AND CONDITIONS

- 1. Your credit terms are 10 days net monthly. All invoices are due for payment by the 10th day of the month following the invoice date.
- 2. If for any reason your payment does not reach us by the due date, and you have not arranged for an extension of your credit facility, your credit agreement will be suspended and any orders placed will be sent on a pre payment basis.
- 3. If payment is still not received within a further 14 days, your account will be put on stop and no further deliveries will be made until the account is brought back within agreed terms.
- 4. If the account remains outside the terms of agreement, and no alternative credit arrangement has been agreed with us, we reserve the right to refer the account to a debt collection agency. In these circumstances all charges, legal fees and interest incurred will be the responsibility of the customer and will be legally enforced.
- 5. We reserve the right to withdraw your credit facility at any time should we have reasonable cause to do so.
- 6. Payment can be made by bacs or card. Please be aware that credit card payments are subject to a 3% surcharge.
- 7. Payments should be accompanied by a remittance advice.
- 8. Any shortages, damages or other problems with deliveries must be notified to us within 24 hours of delivery.
- 9. All goods must be signed for on receipt.

TERMS AND CONDITIONS OF SALE

- 1. All goods offered by Forest Produce Ltd are subject to availability.
- Forest Produce Ltd reserves the right to alter prices, stock and services without notification subject to market fluctuations and variations in relevant exchange rates. However, Forest Produce Ltd will endeavour to advise its customers of any changes where possible.
- 3. All goods must be signed for on receipt.
- 4. All claims for shortages or damage must be notified to Forest Produce Ltd within 24 hours of delivery.
- 5. All goods must be paid for in cash on delivery, except where an account facility has been approved.
- 6. Risk in the goods passes to the buyer on delivery, but title remains vested in Forest Produce Ltd so long as any sum due to the company for whatever reason remains unpaid. The buyer agrees that Forest Produce, in seeking to exercise its rights under this clause, May at any time enter the premises and remove the goods subject of this title.
- 7. Forest Produce Ltd requires payment within agreed credit terms (see above).
- 8. Forest Produce Ltd reserves the right to pursue all overdue invoices by whatever legal means deemed necessary, or by passing the debts to a Credit protection agency, or by any other appropriate means without prior reference to the debtor. Any costs incurred will be passed on to the customer involved
